Valuation is the total cost of construction to the end user, excluding the land purchase costs and the overhead attributed to the land purchase. The value of donated goods and services is included.</p> <p>Notes:</p> <ul style="list-style-type: none"> Plans submitted for a building permit will be charged a non-refundable plan review fee. The fee is calculated at a rate of 25% of the estimated building permit fee. New single-family homes with a valuation of \$115,000 or less shall receive a 50 percent discount on permit fees. A historic building that has been designated by the jurisdiction as a landmark or that is located within a historic district designated by the jurisdiction, or for which designation as a landmark or part of a historic district is pending, shall receive a 50 percent discount on permit fees provided that a certificate of appropriateness issued pursuant to Chapter 33 of the City Code is submitted with the construction documents.
